## Safe travel (Viaggiare sicuri)/Where we are in the world

The site provides citizens with general information on foreign countries, including information on the security situation.

The service, provided by the Ministry of Foreign Affairs and International Cooperation, provides information on the conditions and possible risks to the safety of those who undertake trips abroad, using sources considered reliable, to allow informed and responsible choices. Through the section "Where we are in the world" the service also allows Italians who temporarily go abroad to report personal data - on a voluntary basis - in order to plan rescue interventions more quickly and accurately allowing the Foreign Ministry's Crisis Unit to reach them more easily in case of emergency.

Mobility students must register by accessing the "Where we are in the world" page, in the "School - University - Research" section under "Individual study trips".
